An ordinance

Prescribing certain fees for newborn screening services at the municipal health office of magsaysay, davao del sur.

BE IT ORDAINED by the Sangguniang Bayan of Magsaysay, Davao del Sur, that:

- Section 1. Definition of terms – Newborn screening service (NBS)- is a public health program aimed at the early identification of infants who are affected by certain genetic/metabolic/infectious conditions. Early identification and timely intervention can lead to significant reduction of morbidity, mortality, and associated disabilities in affected infants.
- Section 2. There is hereby prescribed fees for Newborn Screening (NBS) Services at the Municipal Health Office of Magsaysay, Davao del Sur, in the amount of Six Hundred pesos (Php 600.00) per patient.
- The amount covers the procedure and the standard supplies for the procedure.
- Section 3. Administrative Provisions.
1. The Newborn Screening service payment shall be broken down into the following:
 - 1.1 NBS Filter Card Php 550.00
 - 1.2 Service Fee Php 50.00
 2. The amount shall be paid to the Municipal Treasurer's Office or to a designated collector at the RHU, with corresponding issuance of official receipt.
 3. Proceeds from the NBS shall be deposited as Special Fund or Trust Fund for Health which will form part of the local health financing scheme to augment and sustain local health operations.
 4. The fee for Newborn Screening Service as part of the Newborn Care Package of patients who are qualified PHIC Members of dependents shall be shouldered by PhilHealth.
 5. The fees and packages shall be reviewed every three (3) years for possible revision.
- Section 4. Repealing Clause. All ordinances, resolutions, rules and regulations or part thereof which are inconsistent or in conflict with any provision or provisions of this ordinance are hereby repealed or amended accordingly.
- Section 10. Effectivity – This Ordinance shall take effect upon its approval.
