#### RESOLUTION

AUTHORIZING MAYOR ARTHUR D. DAVIN, VICE-MAYOR DONNABEL JOY P. FEROLINO-MEJIA AND MR. WILFRED M. GUILLERMO ALL OF MAGSAYSAY, DAVAO DEL SUR. TO SIGN CHECKS DRAWN AGAINST THE ACCOUNTS OF THE MUNICIPALITY OF MAGSAYSAY FROM ITS DEPOSITORY BANKS.

WHEREAS, the Hon. Arthur D. Davin and Hon. Donnabel joy P. Ferolino-Mejia are the incumbent Municipal Mayor and Municipal Vice-Mayor, respectively, of the Municipality of Magsaysay, having been elected to said positions during the May 13, 2013 National and Local elections;

WHEREAS, both officials assumed their respective present positions at noon of June 30, 2013 pursuant to Article 76 to the Rules and Regulations implementing the Local Government Code of 1991;

WHEREAS, under Section 445 (1) of the Local Government Code the Vice Mayor is authorized to sign warrants drawn for all expenditures appropriated for the operation of the Sangguniang Bayan;

WHEREAS, the Land Bank of the Philippines, Bansalan Branch and the Development Banks of the Philippines, Digos Branch are the depository banks of Municipal Government of Magsaysay, Davao del Sur;

#### NOW, THEREFORE:

BE IT RESOLVED by the Sangguniang Bayan of Magsaysay, Davao del Sur to authorize, as it hereby authorizes Mayor Arthur D. Davin and Mr. Wilfred M. Guillermo, Municipal Treasurer, to sign checks drawn against the LGU's General and Special funds deposited at Land Bank of the Philippines, Bansalan Branch and Development Bank of the Philippines, Digos Branch.

RESOLVED FURTHER, to authorize Vice Mayor Donnabel Joy P. Ferolino-Mejia and Mr. Wilfred M. Guillermo, Municipal Treasurer both of Magsaysay, Davao del Sur. to sign checks drawn for expenditures appropriated for the operation of the Sangguniang Bayan, likewise deposited at the above stated banks under the account of the Municipality of Magsaysay.

RESOLVED FURTHERMORE, to authorize Mr. Pedro D. Calabucal, assistant Municipal Treasurer, Magsaysay, Davao del Sur to automatically countersign checks drawn against the accounts of the Municipal Government from its depository banks in the absence of the Municipal Treasurer.

RESOLVED FINALLY, to furnish copies of this resolution to Mayor Arthur D. Davin and Vice-Mayor Donnabel Joy P. Ferolino-Mejia, both of this Municipality and the branch Managers of Land Bank of the Philippines, Bansalan Branch and the Development Bank of the Philippines, Digos Branch for their information and appropriate action.
