**AN ORDINANCE AMENDING CHAPTER IX OF THE CODE OF GENERAL ORDINANCES OF THE MUNICIPALITY OF MAGSAYSAY, PROVINCE OF DAVAO DEL SUR.**

BE IT ORDAINED by the Sangguniang Bayan of Magsaysay, Davao del Sur, that:

**SECTION 1.** Article 14, Section 1, Chapter IX of the Code of General Ordinances of the Municipality of Magsaysay, Davao del Sur is hereby amended to read as follows:

Article 14 **(1)**. Banning of Open Burning. Any other form of open burning of wastes, including agricultural such as rice straws and rice hulls or “ **Dagami and Bagaso**” and the like shall be banned.

**(2)** Regulation on throwing of Rice Straws, etc. Throwing of rice straws and rice hull (dagami and bagaso) along the roads are strictly prohibited.

**SECTION 2-** Penal Clause. Any person or persons caught and found violating the above-mentioned Article shall be subject to the following penalties:

**First Offense-** Two Thousand pesos (₱2,000.00) or imprisonment of Ten (10) days or both at the discretion of the court.

**Second Offense-** Two Thousand Five Hundred pesos (₱2,500.00) or imprisonment of one (1) month or both at the discretion of the court.

**SECTION 3.** If any provision or part of this Ordinance is declared invalid, other provisions or parts not affected thereby shall remain in full force and effect.

**SECTION 4 - All** Ordinances, Executive Orders and Rules and Regulations inconsistent or in conflict with any provisions of this Ordinance are deemed repealed, amended or modified accordingly.


**SECTION 5 -** Let copy of this Ordinance be furnished to the Office of the Municipal Mayor, Municipal Agriculture Office, Office of the Municipal Administrator thru the MENRO and other Offices concerned for their information and guidance.


**SECTION 6 -** this Ordinance shall take effect immediately upon its approval.
