AN ORDINANCE REGULATING THE PROCEDURES IN SECURING ENDORSEMENT REGARDING QUARRY APPLICATION OF SAND AND GRAVEL AT THE MUNICIPALITY OF MAGSAYSAY, DAVAO DEL SUR.

BE IT ORDAINED by the Sangguniang Bayan of Magsaysay, Davao del Sur, that:

**SECTION 1.** Regulating the procedures in securing endorsement regarding quarry application of sand and gravel, this Municipality, the prerequisites are as follows, to wit.

1. Secure Environmental Impact Inspection Report from the MDRRMC.
2. Submit Environmental Impact Inspection Report to the Sangguniang Barangay concerned where the proposed quarry operation is located.
3. Secure Sangguniang Barangay Resolution from the Barangay where the proposed quarry operation is located
4. Submit the Sangguniang Barangay Resolution to the Office of the Municipal Mayor for endorsement.

**SECTION 2.** The applicant should have any project to be undertaken and exclusively to be implemented within this municipality;

**SECTION 3.** Creation and Composition. The Local Chief Executive shall create an Environmental Impact Inspectorate Team which shall be composed of the Chairman, Vice Chairman and Five (5) Members.

**SECTION 4.** If any provision or part of this Ordinance is declared invalid, other provisions or parts not affected thereby shall remain in full force and effect.

**SECTION 5** - All Ordinances, Executive Orders and Rules and Regulations inconsistent or in conflict with any provisions of this Ordinance are deemed repealed, amended or modified accordingly.

**SECTION 6** -Let copy of this Ordinance furnish to the Office of the Municipal Mayor, Municipal Agriculture Office, Office of the Municipal Administrator thru the MENRO and other Offices concerned for their information and guidance.

**SECTION 7** - this Ordinance shall take effect immediately upon its approval.
