AN ORDINANCE PRESCRIBING RENTAL RATE FOR THE USE OF CERTAIN FACILITIES BELONGING TO THE MUNICIPAL GOVERNMENT OF MAGSAYSAY AND CHARGES/FEES IN AVAILING SPECIFIC SERVICES OF SAID FACILITIES .

WHEREAS, the imposition of charges or fees for the services delivered thereto is vital in government operation which serves as an additional locally sourced revenue of the town, further such revenue is transformed into laudable programs, projects and sustainable development driven endeavors;

WHEREAS, prescribing the rate in the utilization of certain facilities/equipment belonging to the Municipal Government of Magsaysay is incidental to the operation so as to cover maintenance costs of said facilities/equipment among others and further to ensure uninterrupted operation and service delivery;

NOW THEREFORE, BE IT ORDAINED by the Sangguniang Bayan of Magsaysay in session duly assembled:

Section 1 – Prescribing the rental for the use of certain facilities belonging to this Municipal Government, the following charges/fees, to wit;

- A. Option No. 1
  - 1. Function Hall P4,000.00 for the first four (4) Hours  
P500.00 per overtime/succeeding hours
  - 2. Plastic Chair P5.00/unit /8 hours
  - 3. Plastic Table P15.00/unit/8 hours
  - 4. Sound System P700/00 / 8 hours
  - 5. Projector P1,000.00 / 8 hours
- B. Option No. 2 (Package)
  - Function Hall/8 Hours with tables, Chairs and Sound system P6,000.00
  - Overtime per Succeeding Hour P500.00/Hour

Section 2-PROCEDURAL - Interested individual, Cooperative, Corporation or Council, Organization, NGO's, PO's, GO's shall write a letter request addressed to the Municipal Government of Magsaysay. The MEEM Head or the authorized personnel shall verify to the office concerned particularly where the equipment/facilities or service are or under their accountability or control. After verification, payment shall be made at the Office of the Municipal Treasurer. The person concerned shall sign a contract and permit which shall be issued by the Head of the Department/Division Head or authorized personnel.


Section 3- PAYMENTS - all payments for the above service shall be paid thru the Municipal Treasurer's Office or his/her authorized collector and contract of service for lease of equipment and other facilities shall be executed by the Lessor-Office and Lessee-Contractor. Services shall be provided by the former upon payment of exacted rates/fees by the latter

Section 4-REPEALING CLAUSE - all ordinances/resolutions that have been previously enacted by the Municipality and enforced, impositions/charges/fees/rentals/service fee for services similar to that as provided/ordained, are hereby repealed or modified accordingly to conform to the present rates or rules or provisions of previous ordinances.


Section 5-EFFECTIVITY - this Ordinance shall take effect upon its approval.
