AN ORDINANCE

AMENDING ORDINANCE NO. 8 SERIES OF 2017, CREATING THE PLANTILLA POSITION OF THE MUNICIPAL DISASTER RISK AND REDUCTION MANAGEMENT OFFICER (MDRRMO SG-8) UNDER THE OFFICE OF THE MUNICIPAL MAYOR AND DETERMINING THE POWERS, DUTIES AND FUNCTIONS..

Whereas, under the duly approved Municipal Ordinance No. 8, series of 2017, one (1) Plantilla Position of MDRRMO (Salary Grade 8) under the Office of the Municipal Mayor, was created to provide technical assistance in Disaster Risk and Reduction Management operation;

Whereas, on the basis of position classification guidelines and the submitted duties and responsibilities of the position created in said ordinance, Manual of Qualification Standard of Civil Service Commission classified the same as LDRRM Assistant with the same salary grade;

Whereas, to conform with the said position classification guidelines, there is a need to amend the said ordinance by rectifying the position title of MDRRMO to LDRRM Assistant with the same Salary Grade 8.

NOW THEREFORE

BE IT ORDAINED by the Sangguniang Bayan of Magsaysay, Davao del Sur, that:

Section 1 Ordinance No. 8 Series of 2017 is hereby amended by changing the Plantilla Position Title of MDRRMO to LDRRM Assistant under the Office of the Municipal Mayor.

Section 2. Effectivity – This Ordinance shall take effect upon its approval.
