AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 05-2004 ENTITLED “AN ORDINANCE ADJUSTING THE OFFICIAL FARE FOR MOTORIZED TRICYCLE-FOR-HIRE IN THE MUNICIPALITY OF MAGSAYSAY, PROVINCE OF DAVAO DEL SUR”.

BE IT ORDAINED By the Sangguniang Bayan of Magsaysay, Davao del Sur, that:

SECTION 1. Section 1 of the Municipal Ordinance No. 05-2004 of the Municipality of Magsaysay, Davao del Sur is hereby amended to read as follows:

Section 1- The official fare for motorized tricycle-for-hire in the Municipality of Magsaysay, Province of Davao del Sur is hereby adjusted to a minimum fee of FIFTEEN PESOS (P15.00) for the first four (4) kilometers and TWO PESOS (P2.00) for every kilometer in excess of four (4) kilometers, to wit:.

SECTION 2- Section 5. of the Municipal Ordinance No. 05-2004 of the Municipality of Magsaysay, Davao del Sur is hereby amended to read as follows.

Section 5. No tricycle-for-hire operator or driver shall collect from their passenger the allowable fare unless said operator or driver had paid to the Municipal Treasurer the corresponding Fare Adjustment Fee for Fare Increase of THREE HUNDRED PESOS (₱300.00).

SECTION 3. Applicability Clause. – All other matters relating to the impositions in this Ordinance shall be governed by pertinent provisions of existing laws and other ordinances

SECTION 4. Repealing Clause- any and all ordinances or parts thereof which are inconsistent with the provisions of this ordinance are hereby repealed or modified accordingly.

SECTION 5. Effectivity. This ordinance shall take effect upon its approval.
